

# PeeK'in referral program rules

at 30/05/2024

## Article 1: Organising company

The referral operation is organised by the company PeeK'in, based at 4 rue Voltaire, 44000 NANTES and registered with the NANTES Trade and Companies Registry under number 832 852 776.

## Article 2: Dates and deadlines for the sponsorship operation

The referral operation runs from 30 May 2024.

Only complete sponsorships from this date will be counted.

The organising company reserves the right to modify these rules and in particular the dates of the sponsorship operation without prior notice.

## Article 3: Conditions of participation

The referral operation is limited to users of the PeeK'in application, regardless of their position or seniority.

To sponsor a friend, you must be over 18 and live in the UK.

## Article 4: Referral conditions

For a referral to be considered valid, the person referred must :

- be a new customer of the organising company,
- be a hotelier or receptive and work in an establishment with a minimum of 50 keys.

They must meet the following conditions: test PeeK'in for 1 month free of charge, send at least 3 found objects and take out a second month's subscription.

## Article 5: Offers and rewards

The offer given to referred friends is 1 month's free testing of the PeeK'in platform. This offer cannot be combined with other offers. It is valid for all new customers of the organising company making their first subscription thanks to customer sponsorship.

The rewards sent to sponsors for all validated referrals are as follows:  
A €50 gift card or 1 month's free subscription.

The rewards obtained by a sponsor are nominative and cannot be combined with each other or with other commercial offers.

These rewards will be sent within 4 to 8 weeks, depending on the validation and verification of the sponsoree's order and, in particular, their non-retraction.

The organising company reserves the right to modify the rewards without prior notice, particularly in the event of unavailability.

## Article 6: Restrictions, fraud and spam

Any fraud or attempted fraud will be prosecuted in accordance with the provisions of articles 313-1 et seq. of the French Penal Code.

Spamming (sending unsolicited or irrelevant emails or text messages to groups of people) is prohibited for the operation to run smoothly. The organising company reserves the right to definitively exclude from the sponsorship operation any user who is reported to it as not complying with this rule.

The referrer therefore assumes sole responsibility for providing the contact details of his/her referred friends to the organising company. The sponsor undertakes only to provide the contact details of relatives likely to be interested in the products and services of the organising company, for which he/she will have obtained the explicit consent of the sponsored person before.

## Article 7: Applicable law and acceptance of the rules

These sponsorship rules shall be governed by French law.  
In the event of any dispute arising in connection with the sponsorship operation of the organising company, the court of NANTES shall have sole jurisdiction.  
Participants declare that they fully understand and accept these rules relating to the sponsorship operation.
